Sgt. Steve Harding, SSD Rangemaster – Spoke about Range Day. No qualification is necessary if you are staying in the State of California. If you are traveling outside the state you need to qualify once a year. You need to bring 20 rounds of ammo for each weapon you are going to qualify with. If you can't make May 20 you can qualify in July/August or Jan/February. These are the Department qualification times. You can also go to a private range if they have a POST qualified instructor.

Additional Speakers:

Lt. Jim Barnes and Lt. Charles Meeks spoke about a new two day program they would like to start for SSD personnel transitioning from working to retired. The class would cover many topics including where to go to turn in equipment, the CCW process, retired annuitant process, questions from retirees, recognition by Executive Staff that family and friends are invited to attend. You bring your own ammo. The range fee has been waived by Sheriff Jones.

As usual, the range qualifications will start about 0800 and continue until about noon.

The Lunch will be catered by Mike Garcia and the Tai-Mex catering.

The price will be \$15.00 and will include sodas and cold water.
