<u>May 18, 2016, Range Day shoot and Picnic</u>—<u>This is for paid members of the 711 Club.</u> This is a reminder that the annual range day will be held on May 18, 2016, at the Kenneth Royal Range. You are **not** required to qualify for in state CCW authorization.

If you want to qualify for out of state carry (18USC 926c/ HR 218): bring your own weapon, and a holster. You must shoot from a holster. The session is 20 rounds. You must present your SSD ID to shoot.

You bring your own ammo. (20 rounds per line). The range fee has been waived by Sheriff Jones. Range qualifications will start about 0800 hours and the last line is noon. The price will be \$15.00 and will include sodas and cold water. <u>THE LUNCH MUST BE PAID IN</u> ADVANCE DUE TO NO SHOWS.

You must have a R.S.V.P. before May ??, 2016. I need to know if you are going to shoot even if you are not planning on eating.

**Guest Speaker**: Richard Stensrud, SCERS - First question, what will the COLA be in 2016? Effective in the April 2016 checks it will be 4% for Tier 1 who retired before 1979; 2.5% for Safety 1 & Misc Tier 1; Safety Tier 2 and Misc. Tier 3 will be 2%. The extra 0.5% for these members will be banked for a year when the COLA is under 2%.

The investment performance for 2015 was flat but the 3 yr and 5 yr return was 6.9%. The current target is 7.5%. The long-term return was 8.2%. The system uses a 7 year smoothing average so if the market goes up or down drastically it's not a huge hit to the system. The investment portfolio continues to pay for the bulk of retirement. SCERS is going to be doing even more risk analysis. They are also working with the County to establish more autonomy, control and authority for the retirement system. There is State legislation in the works for the 1937 Act counties to allow them to make these changes.

The Sacramento Bee had published an article that said County employees were getting large payouts and "spiking" their pensions. Mr. Stensrud contacted the Bee and explained that those were lump-sum payouts and were not included in pension calculations. The Bee printed a notice of the error and also did a new article that corrected what they had previously reported.

At this time, all pension reform initiatives have been pulled from the ballot. New target date per the sponsors is 2018. Stay tuned.

### Additional Speakers:

Jan Arbuckle – Past Coordinator for the Peer Support Program. Gordon Smith will be assuming that role. Jan is going to focus on a new position that focuses on retirees. She would like feedback on what the Peer Support Program can do for you.
