Kurtis has been an Explorer for five years and Julie for 7 months. The Explorers meet at the Sheriff's Dept. East Division on the 1st and 3rd Thursdays of the month. The program is affiliated with the Boy Scouts and costs \$86 to join, \$36 for Boy Scouts and \$40 for the uniform. The advisors are Sergeant Shelly Hodgkins and various other advisors. The object of the program is to introduce the participants to law enforcement and to explore career paths while serving the community. Explorers must be between the ages of 14-21, a resident of Sacramento County and have a 2.0 grade average. They currently have 35 members with 28 active.

The Explorers used to participate in the Western Regional and National competitions but currently are lacking equipment such as Sam Browne belts, handcuff & radio cases, etc. and funds to pay entry fees.

If an Explorer goes on to the Academy which costs approximately \$5,000 the program picks up half the costs.
