Sheriff McGinness stated that feelings have become more positive throughout the country except for California since 2014. California has passed a few bills that make law enforcement's job tougher.

Prop 47 was marketed as promoting safe schools and neighborhoods. What it did was lower felonies to misdemeanors.

Prop 57 allows the release on non-violent offenders. An amendment to this proposition is being proposed that would take certain non-violent crimes and add them to the violet crimes list.

SB 54 – Proposes sanctuary status for the State of California. Would prohibit any cooperation with the Federal Government relating to illegal immigrants.

May 17, 2017, Range Day and Lunch

This is a reminder that the annual range day will be held on May 17, 2017, at the Kenneth Royal Range. You are **not** required to qualify for in state CCW authorization.

If you want to qualify for out of state carry (18USC 926c/ HR 218):

Bring your own weapon, and a holster. You must shoot from a holster. **You bring your own ammo** -The session is 20 rounds per qualification. **Your Retired ID must be current** to shoot. If it is expired you will not be able to shoot for qualification. Range staff will check for your SSD/Retired ID before they send you to the firing line, to ensure you are an eligible shooter.

The range fee has been waived by Sheriff Jones, for SSD.

As usual, the range qualifications will start about 0800 and continue until about noon.

The Lunch will be catered by Mike Garcia and the Tai-Mex catering.

The lunch is \$15.00 and will include sodas and cold water.

THE LUNCH MUST BE PAID IN ADVANCE DUE TO NO SHOWS.

You must have a R.S.V.P. before Thursday, May 11, 2017. I need to know if you are going to shoot even if you are not planning on eating.
