This question about SSD ID renewal continues to come up. How can I renew my ID without a qualification slip?

Your ID renewal does not require a range qualification slip. The rules have changed in the last few years. Range qualification is **not** required for weapon carry in California, so your renewal is issued with the CCW provision automatically (unless revoked).

You need to have a current ID to shoot at the range. The reason you are qualifying at the range is to make you legal under the federal law in other states. You must carry proof of qualification to show if asked by another state. If you are not local or getting to the range is difficult, you can shoot a qualification course at a private or public range that is legal under the federal law (HR218). If you can't make the 711 Club shoot – you can shoot at our range during open qualifying periods (which are becoming scarce) with a current SSD ID. You need to coordinate with the range to fit in their schedule. Getting your ID renewed takes time because your (request) aka routing slip must be approved which requires several signatures and a background check. The good old days of walking into the office and coming out with a renewed ID are gone. By appointment/invitation only. - Larry Jarvis, Board Member

May 17, 2017, Range Day and Lunch
This is for paid members of the 711 Club

This is a reminder that the annual range day will be held on May 17, 2017, at the Kenneth Royal Range. You are **not** required to qualify for in-state CCW authorization.

If you want to qualify for out-of-state carry (18USC 926c/ HR 218):

Bring your current SSD ID, your own weapon, ammo and a holster. You must shoot from a holster. **You must bring your own ammo** -The session is 20 rounds per qualification. **Your Retired ID must be current to shoot.** If it is expired you will not be able to shoot for out-of-state qualification. Range staff will check for your SSD/ Retired ID before they send you to the firing line, to ensure you are an eligible shooter.

As usual, the range qualifications will start about 0800 and continue until about noon. The range fee has been waived by Sheriff Jones, for SSD.

The Lunch will be catered by Mike Garcia and the Tai-Mex catering.
The lunch is \$15.00 and will include sodas and cold water.

THE LUNCH MUST BE PAID IN ADVANCE DUE TO NO SHOWS.

You must have a R.S.V.P. before Thursday, May 11, 2017. **I need to know if you are going to shoot even if you do not plan to eat.**
