The deputies gave a brief history of the Toy Project which was started in 1984 to teach woodworking skills to inmates. It became a non-profit approximately 15 years ago. They do a float every year for the Santa Parade. The theme for this year is Beauty and the Beast.

If you have any furniture you are thinking of donating, call the Toy Project first at (916) 361-4571. If they have a family that can use the items they will come by and pick up the furniture and distribute.

The Power Program is also located at this site. The inmates go through a two week course to learn some life skills like filling out job applications and how to do an interview. They keep a closet with clothing appropriate for job interviews if you have any donations they can use.

For Christmas they collect toys for ages up to 12 but if there are older children in the family they are not left out. Gift card for Walmart, Target, Kohls are appreciated. Toy Project will also take jackets, new socks, underwear, hats and gloves.

Toy Project also partners with other non-profits such as Project Ride.
