Guest Speaker: Captain Darin Griem-Commander of Courthouse Security

Captain announced that Sheriff Jones is not running for re-election and no one has thrown their hat in the ring yet.

\$80 million has been approved for new buildings at RCCC which will include a new booking, medical and other areas.

Because of AB109 a staffing study was done and it stated RCCC was understaffed. Now they just have to wait for the County to come up with funding. At this time, RBF is closed because of a decrease in inmate population (AB 109).

There are more rehabilitation programs at RCCC because AB 109 includes funding for inmates breaking horses.

The County is also looking at building a new Courthouse and moving the Headquarters building to house all of downtown, north and detectives to one location.
