2018 Sacramento Police Sheriff Memorial Annual Remembrance Ceremony

Thursday, May 3, 2017 12:00 PM, 500 Arden Way (Woodlake Park)

In 1992, the Sacramento Police / Sheriff Memorial Foundation was formed to perpetually honor Sacramento police officers and sheriff's deputies who have been killed or have died in the line of duty. After nearly 10 years, the actual Memorial was completed and dedicated within the Woodlake Park, located at 500 Arden Way in the City of Sacramento. Unfortunately, the names of 33 law enforcement officers from the Sacramento Police Department, the Sacramento County Sheriff's Department, Galt Police Department and the Sacramento County District Attorney's Office are enrolled at this Memorial Site.

Annually, the Sacramento Police / Sheriff Memorial Foundation remembers the fallen officers enrolled in a small Remembrance Ceremony held during the California Peace Officer's Memorial Week.

If your retirement ID is going to expire you need to download the form from the 711 Club website, fill it out, sign it and mail it to SSD ATTN: ID/Live Scan 711 G Street, Sacramento, CA 95814 or deliver in it person for processing. They must have an original (wet) signature. No copy or scan. Call 916-874-8076 to make appointment.

May 16, 2018, Range Day and Lunch

This is a reminder that the annual range day will be held on May 16, 2018, at the Kenneth Royal Range. You are **not** required to qualify for in-state CCW authorization.

If you want to qualify for out of state carry (18USC 926c/ HR 218):

Bring your own weapon, and a holster. You must shoot from a holster. **You bring your own ammo** -The session is 20 rounds per qualification. **Your Retired ID must be current** to shoot. If it is expired you will not be able to shoot for qualification. Range staff will check for your SSD/Retired ID before they send you to the firing line, to ensure you are an eligible shooter.

The range fee has been waived by Sheriff Jones, for SSD.

As usual, the range qualifications will start about 0800 and continue until noon, so qualify ASAP.

The Lunch will be catered by Mike Garcia and the Tai-Mex catering.

The lunch is \$15.00 and will include sodas and cold water.

THE LUNCH MUST BE PAID IN ADVANCE DUE TO NO SHOWS. Pay at the March or April meetings.

You must have a R.S.V.P. before Thursday, May 10, 2018. I need to know if you are going to shoot even if you are not planning on eating.
