**Guest Speakers:** Crystal Harmon from Sunrise Senior Living Facility of Sacramento. This facility provides assisted living & memory care mostly for long-term residential residents. Monthly cost starts at \$3,500 a month and up depending on what services you need. They are a full service facility that operates on a month to month basis. They also offer a short term stay for when you can't live by yourself due to a broken body part, recovering from surgery, etc. This care runs approximately \$200 a day. ### By Law changes:

At the Board of Directors meeting on July 25, 2018 we discussed the need for bylaw changes. Current ByLaw IV gives voting authority to the Board of Directors, specifically naming the 6 elected members designated as Directors, for conducting the business of the association. It does not mention or exclude the elected officers (President, VP, Secretary, Treasurer, Sgt At Arms, Immediate Past Pres). In order to make this less vague, and formally authorize the Officers to vote at Board meetings. The following changes were approved by the Board, to be presented to the general membership. They must be approved by YOU in order to take effect. There will be a vote at the NOVEMBER meeting on this issue.

Also, language has been changed to allow the Vice President to vote on all matters at Board meetings, and changing the status of the Immediate Past President to a non-voting advisor.

The changes are as follows. Current language that will not be changed is in regular font. Current language proposed to be changed is in 'strike-thru' and the proposed new language is in italics.

### BY LAW IV

#### STRUCTURE OF OFFICERS

The officers of the Association shall be:

1. President
2. Vice President
3. Treasurer
4. Secretary
5. Sergeant of Arms
- ~~6. Immediate Past President~~

#### BOARD OF DIRECTORS

The Board of Directors shall consist of ~~the Vice President As Chairperson~~ *the above named officers of the Association* and six elected members. All business of the Association shall be carried out by the Board of Directors, by majority vote of a quorum. A quorum shall consist of at least ~~three (3)~~ *six (6)* members of the Board of Directors *present, or voting by proxy. The Vice President shall serve as Chairperson of the Board of Directors.*

#### Duties of the Officers of the Association:

1. The President shall:
  - A. Serve as the Chief Executive Officer of the Association.
  - B. Preside over all membership meetings. In the event of his/her absence and that of the Vice President, the president shall appoint a designee to chair the meeting.
  - C. Make suggestions to and carry out the directions of the Board of Directors.
  - D. Appoint committees, members of those committees, and the chair of each standing committee and other committees as authorized by the Board of Directors.
  - E. Be authorized to expend up to \$100.00 without Board of Directors approval for necessary and reasonable Club expenses.
  - F. In the absence of the Vice President, the President may act as the ex-officio Chairperson of the Board of Directors ~~and may vote only in the event of a tie.~~
  - G. The immediate past president shall serve in an advisory capacity to the President and the Board of Directors. He/she may attend meetings of the Board of Directors, but will have no vote.*
2. The Vice President shall:
  - A. Act in the President's absence and act as Chairperson of the Board of Directors ~~and shall only vote in the event of a tie.~~
- 3-5. No changes.
- ~~6. The Immediate Past President shall serve in an advisory capacity to the President and the Board of Directors.~~
