May 22, 2019, Range Day and Lunch This is for paid members of the 711 Club

This is a reminder that the annual range day will be held on May 22, 2019, at the Kenneth Royal Range. This is the **4th** Wednesday.

You are **not** required to qualify for in-state CCW authorization.

If you want to qualify for out of state carry (18USC 926c/ HR 218):

Bring your own weapon, and a holster. You must shoot from a holster. You bring your own ammo -The session is 20 rounds per qualification. Your Retired ID must be current to shoot. If it is expired you will not be able to shoot for qualification. Range staff will check for your SSD/Retired ID before they send you to the firing line, to ensure you are an eligible shooter.

The range fee has been waived by Sheriff Jones, for SSD.

As usual, the range qualifications will start about 0800 and continue until about noon.

The Lunch will be catered by Mike Garcia and the Tai-Mex catering. The lunch is \$15.00 and will include sodas and cold water.

Cola for Tier 1 Retires' will be 4%. Tiers 3,4,5 will receive 2%. The retirement system is funded at 82-83% due to conservative investments. There was a 10% return for the Fiscal Year ending June 30,2018 and 7% is being projected for 2018/19.

The system has been working hard to get new retirees applications processed faster. Have changed the procedures and hired more people. Most first checks are going out in 45 days. They are processing approximately 800 applications a year. New automated system is in the works to replace the manual system. Should be available in approximately two years. Additional changes that have happened this year are the SCERS News Letter starting again and a new SCERS EIN number for tax purposes.

SCERS is working with the County and DSA on how many years annuitants can work. You can only work 960 in a year. Everyone would be able to work for an initial three-year period with a possible extension for an additional two years. Law enforcement (including some non-sworn positions) would be exempt.
