

Sunshine Report: Presented by John Woodhouse: Mike Wagenhals is not doing well; Tom Leonard, Dept of Corrections, passed in May 2019.

Color Guard: The colors were presented by the Young Marines Honor Guard affiliated with the Sacramento Sheriff's Department Youth Activity League. Deputy Sheriff Hank Nguyen spoke to us about the program. It is a National Youth Program to train kids to be leaders of tomorrow. Kids get the opportunity to meet veterans and get to know them. Members from 8-16 get to travel to different events in different cities.

Guest Speaker: Carol Daly, retired Undersheriff, on the East Area Rapist Case: Carol talked about her part in the Sacramento cases and how she has kept in touch with the victims over the years. She has also talked to the Media on multiple occasions. At the start of the investigation, there were no cell phones or DNA. Reports were typed on typewriters. In 2011 connections were made between the North state and South state cases. Sheriff Jones called Carol to tell her the East Area Rapist had been identified and was in custody. Carol met with the victims at her home after the 1st two court dates. All cases will be prosecuted in Sacramento because of the detailed reports in Sacramento County.
