Meeting Minutes

Date: February 12, 2020 Location: SCDSA Facility 640 Bercut Drive, Sacramento

Meeting was called to order at 12:00 p.m. by President John Woodhouse Pledge of Allegiance was recited by all present.

Sunshine Report: Presented by Earl Evans: Tim Alton passed away after a long battle with Brain Cancer. John Greasby's wife passed away. (Crazy) Larry Saunders has been hospitalized with an infection. He's out of the hospital, now. Mike Wagenhals is back in the hospital, but is improving. Ray Biondi passed away this morning.

Speakers: Tom Neri and Todd Kell and the "Wild Horse Project" at RCCC

The horse project at RCCC was started in 2012. Due to the California Corrections & Rehabilitation Department's restructuring that sent state prisoners to the county facilities, RCCC needed to develop programs for the inmates. The RCCC Captain authorized the Wild Horse Project. The property for the project is behind the range, between the range and airport. One cowboy was hired to train the inmates and the horses.

The inmates are screened for the project and once chosen are assigned a horse. The cowboy instructs the inmates in 6 levels of training starting with gaining the horse trust and continuing to the bridle, saddle, and obedience. After the horses are trained, they are auctioned off the to the public. These auctions are held every 3-4 months. The next auction will be **May 30th**. So far 128 horses have been adopted. SPD has two horses from the project currently patrolling the streets, SSD has one horse, CHPD has one, Bureau of Land Management has 2 and Yosemite has two.

Most of the horses come from the Susanville area. The project is allotted 40 horses.

Each inmate gets a certificate when he and his horse complete each level of training and a certificate when all six levels of training are completed. One graduate of the program has become a farrier and has a horse-shoeing business. He returns to the work at the Project, teaching the inmates horse-shoeing, showing "if I can do it, you can do it."

The recidivism percentage rate for the inmates in the project is high teens to lower 20's.
