From the President

Hello 711 Club members. Our April, 2021 meeting was held on Wednesday, April 14th at the SCDSA office. We had some 34 members in attendance, slightly up from the last several meetings. I attribute this to two main factors, an interesting guest speaker and also that more people have been vaccinated against Covid or are in the process of doing so. I've had my first shot of the Moderna vaccine, awaiting the second.

Our guest speaker was Supervisor Sue Frost, from the Sacramento County Board of Supervisors. Supervisor Frost delivered what I found to be an interesting and poignant presentation, addressing areas of concern such as the homeless problems in our County, new procedures being studied for handling 5150 calls by mental health professionals, and the County budget, to name a few. I enjoyed and learned from listening to her speak, and received positive feedback from a number of those in attendance.

Also discussed was the upcoming shoot/picnic day at the Kenneth Royal firearms range. The shoot will be held Thursday, June 3rd 2021 from 0800 until noon. The shoot is in June this year instead of May because the range schedule is very busy and the rangemaster was unable to squeeze us in during May. June 3rd will be Range Day and the June meeting. Qualification lines continuously from 0800 until noon. Each shooter must have ID. Each shooter must furnish his/her own ammunition, and have an appropriate holster for each weapon being qualified with. Shooters may qualify with more than one firearm. Completion of this course will qualify members for the out-of-state carry (19USC926c). Shooters MUST qualify with the specific weapon to be carried, and the weapon's serial number is recorded on the qualification form. You may not use a similar one.

The amendment to the 711 Club's by-law concerning the change to the voting procedure was enacted. A sufficient number of proxy votes was received and those in attendance unanimously voted in favor of it, to satisfy the 10% of the total membership required by the previous by-law. In short, the new by-law requires only a simple majority of those in attendance at a meeting where a vote is held, in order to carry a motion.

The BOD and Club officers planned to have a Board meeting at the conclusion of the general membership meeting.

Bring your own weapon, and a holster. You must shoot from a holster. You must bring your own ammo -The session is 20 rounds per qualification. Your Retired ID should be current to shoot.

As usual, the range qualifications will start about 0800 and continue until about noon.

Meeting Minutes

Date: April 14, 2021 **Location:** SCDSA Facility 640 Bercut Drive, Sacramento

Sunshine Report: Margaret Madrigal is doing well after heart surgery.

Speaker: Supervisor Sue Frost (District 4) - **Budget** – In 2020 the County was anticipating hundreds of layoffs due to the economy and lawsuits that had been settled including one for the jails to address dangerous/unsafe conditions. The County received \$200,000 in COVID money which helped balance the budget. In 2021 the County anticipates receiving approximately \$300,000 in one-time Recovery Act money. Supervisor Frost would like the County to use some of the money to increase the reserves and advocate for helping small business, mental health and park districts.

Supervisor Kennedy and the State are looking at a program that would dispatch non-law enforcement personnel to mental health calls. County is on hold pending State action.

Laura's Law (AB 1421) (Assisted Outpatient Treatment (AOT)) – This was signed into law in 2002 and originally was an Opt-In program. AB 1976 went into law making it required unless Counties Opt-Out by July 21, 2021.

COVID –Governor Newsom declared a State of Emergency (SOE) due to COVID (March 4, 2020). This order states all Californians will heed State public health directives from the Department of Public Health. With the SOE you can ask for help from FEMA and others. It also supersedes the rights granted to local public health officers under AB 262.

Old Business:

By-Law Change – At the Board of Directors Meeting on February 10, 2021 your board voted to present changes to By-Law 5, paragraph 5. The changes were sent out by email February 25, 2021 and mailed to members without email addresses. This by-law has been re-written to need only a quorum of regular members present to vote by voice or show of hands at any meeting where a vote is taken. Proxies may be given in writing to any Officer or Board Director attending the meeting, to be used in the member's absence. This by-law will be voted on at the April 14, 2021 General Meeting. UPDATE: At the April 14, 2021 meeting a motion was made to approve the by-law change as outlined above by Cliff Lunetta and seconded by Bob Stevens. There were 51 Ayes and no Nays or Abstentions. Motion passed

Range Day – Will be Thursday June 3, 2021 – 8 am till 12 pm. You will need your ID, holster and 20 rounds of ammo (holster & ammo for each weapon you are qualifying with). If you are qualifying for out of state, it must be the weapon you carry, not a similar type. There will be a lunch signup and pre-pay (\$20.00) at the May meeting.
